**October 21, 2024**

Director Dollenmayer read the Regular Agenda. Rule 109:4-3-31 of item 1 was moved to the review portion of Committee. Co-Chair Gavarone called for questions or comments on the remaining items of the Regular Agenda. No additional questions or comments were given from the Committee or public.

Co-Chair Gavarone reminded the four agencies who did not meet the Senate Bill 9 required regulatory restriction reduction of 20% for fiscal year 2024 that they are given the opportunity to appear before JCARR at the November 12<sup>th</sup> hearing to address the progress that has been made.



Co-Chair Gavarone adjourned the meeting at 1:38 PM.


