Co-Chair Gavarone called the meeting to order at 1:32 p.m.

Legal Counsel Honor Banvard called the roll. Representatives Callender, Hillyer, Mathews, Skindell, and Humphrey and Senators Gavarone, Brenner, Craig, and DeMora were in attendance. Senator Reynolds was substituting for Senator Kunze. Ms. Banvard stated a quorum was present.

Co-Chair Gavarone asked the Committee members to review the April 15, 2024 minutes. The minutes were approved as presented.

Director Dollenmayer read the No Change Agenda. Co-Chair Gavarone called for questions or comments on the No Change Agenda. With respect to item 3 on the No Change Agenda, rules of the Department of Transportation, Division of Aviation, Representative Hillyer asked about the status of a House bill regarding navigable airspace. Co-Chair Gavarone stated she was not aware of discussions on the bill.

Director Dollenmayer read the Regular Agenda. Co-Chair Gavarone called for questions or comments on the Regular Agenda. With respect to item 34 on the Regular Agenda, rules of the Secretary of State, Josh Jaffe, Director of Data Analytics, appeared on behalf of the Secretary's office and answered questions from Senator DeMora regarding funding. With respect to items 11 and 12 on the Regular Agenda, rules of the Department of Commerce, Division of Cannabis Control, Co-Chair Gavarone noted that the Committee had received written testimony from Herb Washington of Parkland Ventures LLC. Jim Canepa, Superintendent of the Division, answered questions from Senator DeMora, indicating that the rules implement the initiated statute that was approved by voters in 2023. Co-Chair Callender and Senator DeMora each thanked the Division for its work on the rules.

Co-Chair Gavarone reminded the public of the next JCARR meeting on Monday, June 3, 2024 at 1:30 p.m. in the Senate Finance Hearing Room.

Co-Chair Gavarone adjourned the meeting at 1:42 p.m.
