Co-Chair Gavarone called the meeting to order at 1:32 p.m.

Legal Counsel Honor Banvard called the roll. Representatives Callender, Hillyer, and Humphrey and Senators Gavarone, Kunze, Brenner, and Craig were in attendance. Representative Dobos was substituting for Representative Mathews and Senator Sykes was substituting for Senator DeMora. Representative Skindell was excused from the meeting. Ms. Banvard stated a quorum was present.

Co-Chair Gavarone asked the Committee members to review the May 13, 2024 minutes. The minutes were approved as presented.

Deputy Director Fouche read the No Change Agenda. Co-Chair Gavarone called for questions or comments on the No Change Agenda. There were no questions or comments from the Committee or public. Deputy Director Fouche read the Regular Agenda. Rule 3745-32-04 of item 47 on the Regular Agenda was moved to the review portion of the agenda. Co-Chair Gavarone called for questions or comments on the remaining items on the Regular Agenda. Co-Chair Callender expressed appreciation to the Department of Education and Workforce for having placed a gifted education rule, rule 3301-51-15 of item 53 on the Regular Agenda, into To Be Refiled status.

Co-Chair Gavarone recognized the following individuals to provide testimony on rule 3745-32-04, an Environmental Protection Agency rule addressing mitigation for impacts to streams: Vincent Messerly, President of Stream + Wetlands Foundation; Joshua White, Vice President of Water & Land Solutions, LLC; and Bradley Petru, Senior Project Manager for Civil & Environmental Consultants.

Mark Johnson, Chief of the EPA Division of Surface Water, appeared on behalf of the EPA and stated that rule 3745-32-04 would be placed into To Be Refiled status.

Co-Chair Gavarone reminded the public of the next JCARR meeting on Monday, June 24, 2024 at 1:30 p.m. in the Senate Finance Hearing Room.

Co-Chair Gavarone adjourned the meeting at 2:06 p.m.
