**June 13, 2022**

Chair Gavarone called the meeting to order at 1:33 p.m.

Representative Humphrey was substituting for Representative Boggs. Deputy Director Fouche stated a quorum was present. Chair Gavarone asked the Committee members to review the May 16, 2022 minutes. The minutes were approved as presented.

Director Wolpert read the No Change Agenda. The Chair called for questions or comments on the No Change Agenda. There were no questions from the Committee or the public. Director Wolpert read the Regular Agenda. Rule 901:1-6-08 of item two on the Regular Agenda was moved to the review portion of the agenda. The Chair called for questions or comments on the items other than rule 901:1-6-08 on the Regular Agenda. There were no questions or comments from the Committee or the public. Chair Gavarone temporarily recessed the Committee at 1:37 p.m.

Chair Gavarone called the meeting back to order at 1:38 p.m. to discuss the review portion of the agenda. Chair Gavarone called Vicki Deisner, Animal Welfare Institute to provide proponent testimony on 901:1-6-08. Representative Callender thanked ODA and stakeholders for their work on the rule. Representative Skindell, requested that ODA engage with stakeholders in the future regarding rechecking background checks.

The Chair reminded the public of the next JCARR meeting on Monday, July 11<sup>th</sup> 2022.

The Chair also shared that the JCARR meetings in August and October were combined and are now occurring on Wednesday, August 17<sup>th</sup> and Monday, October 17<sup>th</sup>.
