Representative Mathews served as temporary Co-Chair for Representative Callender. Director Dollenmayer stated a quorum was present.

Co-Chair Gavarone asked the Committee members to review the June 10, 2024 minutes. The minutes were approved as presented.


Co-Chair Gavarone adjourned the meeting at 10:04 AM.


