Co-Chair Gavarone called the meeting to order at 1:30 PM.

Co-Chair Gavarone recognized the substitute members joining the committee, and Deputy Director Fouche called the roll. Present were Representatives Hillyer, Lorenz, Dobos, Skindell, and Humphrey; as well as Senators Gavarone, Kunze, Brenner, Craig and DeMora. Representative Dobos substituted for Representative Mathews, Representative Lorenz substituted for Representative Callender, and Representative Hillyer served as temporary Co-Chair for Representative Callender. Deputy Director Fouche stated a quorum was present.

Co-Chair Gavarone asked the Committee members to review the June 25, 2024 minutes. The minutes were approved as presented.

Director Dollenmayer read the No Change Agenda. Co-Chair Gavarone called for questions or comments on the No Change Agenda. There were no questions or comments from the Committee or public.

Director Dollenmayer read the Regular Agenda. Rule 3301-51-15 of item 3 on the Regular Agenda was moved to the review portion of Committee. Co-Chair Gavarone called for questions or comments on the remaining items of the Regular Agenda. There were no questions or comments from the Committee or public.

Co-Chair Gavarone recognized Abbie Sigmon, Executive Director of the Ohio Association for Gifted Children, to provide testimony on rule 3301-51-15: an Ohio Department of Education and Workforce rule addressing standards for identifying and serving students who are gifted. Representative Dobos requested to hear the Ohio Department of Education and Workforce's response.

Ashley Frustaci, Deputy Chief Legal Counsel of the Ohio Department of Education and Workforce, appeared on behalf of the Ohio DEW to address issues raised during testimony. Ms. Frustaci took questions from Representative Skindell and Senator Brenner, clarifying that DEW would place this rule into To Be Refiled (TBR) status.

Co-Chair Gavarone reminded the public of the next JCARR meeting on Monday, August 12, 2024 at 1:30 PM in the Senate Finan Hearing Room – Room 126.

Co-Chair Gavarone adjourned the meeting at 1:43 PM.
