**September 9, 2024**

Co-Chair Gavarone called the meeting to order at 1:30 PM.

Deputy Director Fouche called the roll. Present were Representatives Callender, Hillyer, Mathews, Skindell, and Humphrey; as well as Senators Gavarone, Brenner, Craig, and DeMora. Senator Reineke substituted for Senator Kunze. Deputy Director Fouche stated a quorum was present.

Co-Chair Gavarone asked the Committee members to review the August 12, 2024, minutes. The minutes were approved as presented.

Director Dollenmayer read the No Change Agenda. Co-Chair Gavarone called for questions or comments on the No Change Agenda. There were no questions or comments from the Committee or public.

Director Dollenmayer read the Regular Agenda. Rules 4723-24-01 to 4723-24-07 of item 1 and Rule 3301-51-15 of item 12 were moved to the review portion of Committee. Co-Chair Gavarone called for questions or comments on the remaining items of the Regular Agenda. There were no further questions or comments from the Committee or public.

Co-Chair Gavarone reminded agencies subject to Senate Bill 9 reporting that September 15<sup>th</sup> is the deadline to submit their fiscal year 2024 Regulatory Restriction Reports and Revised Inventories to JCARR.

Co-Chair Gavarone recognized Marie McCausland, Chair of the Doula Advisory Group for the Ohio Board of Nursing, to provide testimony on Rules 4723-24-01 to 4723-24-07: Ohio Board of Nursing rules regarding Doula certification, standards of practice, and disciplinary actions. Co-Chair Callender noted the desired changes would require legislative action as the rules were in line with the authority and direction currently given by the General Assembly to the agency. The Committee acknowledged Ms. McCausland's suggested changes for the next legislative session.


Co-Chair Gavarone directed the Committee's attention to written testimony submitted by Abbie Sigmon, executive director of the Ohio Association for Gifted Children, on rule 3301-51-15: an Ohio Department of Education and Workforce rule addressing standards for identifying and serving students who are gifted. Representative Skindell thanked the Department of Education and Workforce for their work on this rule and looked forward to a future legislative fix.

Co-Chair Gavarone reminded the public of the next JCARR meeting on Monday, September 30, 2024, at 1:30 PM in the Senate Finan Hearing Room – Room 126.


Co-Chair Gavarone adjourned the meeting at 1:48 PM.


